1.13. From which sources we retrieve the information?

The most personal data is retrieved directly from you when you provide it in your messages, requests, impulses submitted by our contact form at www.reformcapital.skor reporting any change of it, by your presence in our web site www.reformcapital.skor using functionalities of our web site;

- **1.14. Information on existence of automated decision-making including profiling**(including information on applied procedure as well as significance and assumed impacts of such processing for the data subject):
 - 1.14.1. Should you visit our internet sites, we save in your device and then we read from it small files like cookies. Cookie is a small file of numbers stored in your internet browser or hard disk of your computer. Some cookies enable us to connect your activities during browsing our sites from the moment you open the window of your web browser until you close it. In the moment you close the window of the internet browser such cookies are deleted.

Others remain in the device for a set period of time and are activated always when you visit the web site which created the specific cookies. Further, we use pixel signs (known as web beacons), which are small pictures having the similar function as cookies. Compared to cookies which are stored in the hard disk of your computer, pixel signs are a part of internet sites (hereinafter cookies and beacons referred as "cookies").

The reason for making use of cookie is especially for publishing of inserted contributions, monitoring of visits, and improving of our services. In case you register with us, we make use of your data for keeping your account and providing related functions. By means of your contacts and other data we display and send you our offers. Your data are used also when you place an order for goods through our shopping cart and during solution of eventual claims if required by a law and also for protection of our legal claims.

1.14.2. Cookies also help us:

- 1.14.2.1. to identify you when browsing individual sites (cards) of our web site and revisiting to remember your log in from a specific device or to store the version of our web site to display for you in case the web site offers several versions at the moment;
- 1.14.2.2. to provide for security, for instance, to avoid someone to misuse your connection to our web site and act instead of you;
- 1.14.2.3. to register, explore, and remove breakdowns and non-functioning parts of our internet sites;
- 1.14.3. Data on your behaviour on our internet sites is collected not only from cookies, we collect also data like:
 - 1.14.3.1. IP address of your device (address of your device by means of which you communicate with other devices in the internet);
 - 1.14.3.2. the operation system of your device, its version, and language setting;
 - 1.14.3.3. the browser you use at your device, its version, and language setting;
 - 1.14.3.4. address of web site (URL address), from which you access our internet sites;

Unless you disable use of cookies in settings of your web browser and after our notice you click any link to our internet site or click the button "I understand", which is a part of the notice, we will legitimately suppose that you agree with use of cookies. You can anytime withdraw your consent by disabling use of cookies in settings of your web browser.

Simultaneously, you are entitled to object processing in compliance with Sect. 1.10.1 hereof.
